9.1 Medical Officer of Health Update Dr. Kit Young Hoon, Medical Officer of Health. Reference #2024.10.25-9.1; the Report will be kept on file.

Dr. Young Hoon shared some highlights of her written report including the positive news that the RRDOHT has onboarded an Executive Lead, and NWHU offered input into their operational plan.

Vaccine clinics are up and running for both Influenza and COVID; everyone is encouraged to get vaccinated.

It was highlighted that NWHU is working with the City of Kenora's Crime Prevention and Community Well-being committee on needle waste mitigation efforts.

As outlined in the report, many homes in our region rely on private drinking water systems such as wells and lake water. These people count on testing to ensure their drinking water is safe. Currently, testing is free through Public Health Ontario (PHO) labs with a small fee for shipping.

PHO currently has a proposal into the Province regarding Well Water Testing, but no information is available to PHUs as to the details of the proposal, and health units and municipalities in the province are calling for this free service to continue to protect the health of Ontarians who consume water from private drinking water systems.

WHEREAS many residents in Northwestern Health Unit's service area rely on private drinking water systems such as wells; and	
WHEREAS it is recommended that drinking water be tested frequently to ensure it is safe for human consumption; and	
WHEREAS exposure to contaminated drinking water can lead to severe gastrointestinal illness, which in rare cases may resolute in death; and	
WHEREAS anyone can become ill from drinking contaminated water; however children, older adults, and people with weakened immune systems are at a higher risk of the harmful effects; and	
WHEREAS the Public Health Ontario (PHO) Well Water Testing program is a publicly funded service that tests water samples from private drinking water sources for indicators of bacterial contamination; and	
WHEREAS testing drinking water quality at private laboratories can be cost prohibitive; and	
WHEREAS the Auditor General in its December 6, 2023 Value for Money Audit: Public Health Ontario called for Public Health Ontario and the Ministry of Health to move forward with streamlining laboratory operations in consideration of the proposed modernization plans; and	
WHEREAS Public Health Ontario and the Ministry of Health have not yet announced a final plan for streamlining laboratory operations at this time;	
NOW, THEREFORE, BE IT RESOLVED THAT the Board of Health for the Northwestern Health Unit strongly recommends to the Minister of Health and to Public Health Ontario that Ontario's Well Water Testing program fully
